TERMS & CONDITIONS:-

- 1. Price quoted should be F.O.R.Our factory at Mohan/Ramnagar) and must include all charges of packing** and delivery as applicable along with Draft amounting to Rs. 250/- (Cost of Tender Form) favouring “ Indian Medicines Pharmaceutical Corporation Limited Payable State Bank of India, Mohan (Via – Ramnagar) (Branch code 5676).
- 2. Party deposit earnest money in the form of TDR/FDR pledged to Indian medicines Pharmaceutical Corporation Limited” for Rs. 5000/- (Rs. Five Thousand only).** Earnest money earlier deposited & kept in the company unforfeited can be taken consideration at the request of the party (Copy of TDR/FDR or detail of the same be provided for getting exemption).
- 3. Rates should be valid for 12 months from the date of opening of tender.** Revision of rate in any case due to increase of raw material cost etc, decision of management/company will be final.

4. Tender will be opened on 28.09.2011 at 3 PM. The supplier has liberty to be present or authorize a representative at the time of opening of the Tender at date and time fixed.

6. Delivery required:- As and when required.
7. The deal is liable to be terminated at any time notice at our discretion in case of complaint/unsatisfactory service / undue delay / repeat regrets / rejections in supply of items.
8. Supplier will have to provide certificate of food grade raw material used for manufacturing of Plastic PET items.
9. We reserve the right to disapprove or reject the items supplied, which are not in accordance with the samples specifications and approved by the Company. The rejected items will be returned to the supplier at their own cost and supplier will be bound to replace the same within 10 days.
10. In case of controlled goods by the Govt. the quotation must be sent subject to the controlled price or rates offered by you whichever is less. Quotations of controlled goods must be clearly mentioned in your quotation market preferably with red ink.
11. Conditional offer will be rejected, or accepted in the discretion of the Company.
12. The company does not pledge itself to accept the lowest or any other quotation and reserve to itself the right to accepting the whole or any part of the quotation and supplier shall supply the goods at the rate quoted. The supplier is at liberty to quote for supply only if the entire quantity is taken from the supplier.
13. The Company will be not be responsible for delay,/loss or non-receipt of quotation sent by post and is not bound to entertain any correspondence in this regard.
14. The offer can be ignored if incomplete information is given of any data/documents are not duly filled or furnished.
